

# Herby Spring Chicken Pol Pie



#### Ingredients:

2 tbsp olive oil plus a little extra for brushing over the pastry bunch green onions sliced into 1 inch pieces 250g frozen spinach 6 ready-cooked chicken thighs (or see tip, below) 350ml hot chicken stock ½ tbsp wholegrain mustard 200g frozen peas 200ml half-fat crème fraîche

½ small bunch tarragon leaves finely chopped small bunch parsley finely chopped 270g pack filo pastry

#### **Directions:**

Heat oven to 375F. Heat the oil in a large, shallow casserole dish on a medium heat. Add the green onions and fry for 3 mins, then stir through the frozen spinach and cook for 2 mins or until it's starting to wilt.

Remove the skin from the chicken and discard. Shred the chicken off the bone and into the pan, and discard the bones. Stir through the stock and mustard. Bring to a simmer and cook, uncovered, for 5-10 mins.

Stir in the peas, crème fraîche and herbs, then remove from the heat. Scrunch the filo pastry sheets over the mixture, brush with a little oil and bake for 15-20 mins or until golden brown

# Did I Waive My Rights?

In today's world, almost every business or activity requires you to sign a **waiver** before engaging or participating in an activity or service. Most Florida businesses, schools, and organizations require that their customers or participants sign a "**liability waiver**", also known as a "**liability release**", before they are allowed to participate in the activity or service offered.

#### What is a liability waiver/ release?

It is a legal document that is given to the customer/participant which states that the activity or service that the customer/participant wants to engage in has potential risks involved and if those potential risks cause injury, the business, school, or organization will not be responsible. In other words, by signing this legal agreement, the customer/participant has agreed to waive their right to sue the business, school, or organization for their injuries caused while participating in the activity or service.

#### What activities/services typically require a waiver?

Sports activities
Gym and recreational activities
Theme parks
Cosmetic and aesthetic services
Rentals of equipment and vehicles, just to name a few

#### What language is typically found in a valid Liability waiver?

Assumption of Risk - This language states that you understand the risks involved in the activity or service you are going to participate in and you are willing to go forward with it anyway.

Release of Liability - This language explains that despite the risks involved in the activity or service, you will not hold the business, school, or organization responsible for any injuries that occur as a result of your participation.

Acknowledgement of Understanding – This language states that you have had the opportunity to read the entire document, ask questions and understand fully what you are doing by agreeing to sign the **waiver**.

#### Can you attack a waiver?

Yes. The Florida Courts will strictly review a **waiver** in a case where someone was injured while participating in an activity or service that involved risks. The Court will look at the following factors to determine the validity of the **waiver**;

**Is the language of the waiver vague and ambiguous** - The Court will require that the release language be clear and unambiguous so that a person understands what rights they are giving up by signing the **waiver**.

The waiver must specifically outline the risks associated with the activity or service that the customer/participant is releasing the business, school, or organization from.

The waiver must have been entered into voluntarily by the customer/participant.

Once the Court has determined the validity of the **waiver**, then it can look at several other circumstances in which they could decide that the **waiver**, despite its legal validity, does not apply because of the egregious behavior of the business, school, or organization. Those circumstances are;

**Gross Negligence** – Was the Business', school's, or organization's behavior reckless or so far below a reasonable standard of care or safety that it voided the **waiver** signed by the customer/participant.

**Intentional Act** – Did an employee, agent or representative of the business, school, or organization commit an intentional act against the customer/participant causing them injury. If that occurred, then the **waiver** would not apply.

A parent or guardian can sign a **waiver** on behalf of a minor, but the release language in this type of **waiver** has to be very specific and in large print.
